Live Music – Live Music will be performed on the first floor of the premises. Solo artists, singers with backing music, instrumentalists, live bands will all be sought to perform for customers enjoying a quiet drink and some light snacks. The music will not be amplified, except where bands bring their own equipment – in which case noise will be kept to acceptable levels to create the ambient atmosphere. It is envisaged most events will be held after 19:00.

Recorded Music – corporate and/or private functions will be offered for the first floor where disco equipment will be set up on the stage area. Music will be played from 19:00 onwards. When used for non-corporate/private use, the music will be varied to suit the customers and to create a fun yet relaxing attractive and enjoyable environment.

Application for provision of entertainment throughout the year, mostly in the evenings, though may be quiet, relaxing music during the day too.

Performance of Dance – Instead, or to compliment the live or recorded music, live dancers or dance acts could be invited to entertain customers. This will not be any form of erotic dancing which may cause concern for the well being of children and prevent them from coming into the establishment.

Provision of facilities for dancing

A small dance floor to compliment the live music and/or recorded music. Seating will remain on the ground floor and there will be bar stools and relaxation area on the first floor for customers to enjoy their drinks and food.
